- d. Conduct such other activities that would engender a safe environment in school campuses and training-related programs in HEIs.

On behalf of the Ateneo de Manila, I would like to thank the new members of the CODI for their gracious acceptance of this mission.

Let us support the new CODI members with our cooperation and prayers as we work together to create a safer school environment. May the Holy Spirit grant them wisdom in their deliberations and recommendations.
